

ORDINANCE NO. 32

AN ORDINANCE AMENDING ARTICLE 17 RELATING TO FEES OF ZONING ORDINANCE NO. 23 ENACTED JUNE 1, 1971.

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1: Article 17 relating to Fees of Zoning Ordinance No. 23 enacted June 1, 1971, is hereby amended as follows:

ARTICLE 17. FEES

SECTION 17.01 FEES:

1. Fees are for the purpose of defraying administrative costs.
2. Fees payable at the time of application shall be:
 - A.....Zone Change - \$100.00
 - B.....Condition Use - \$100.00
 - C.....Expansion of a Non-Conforming Use - \$50.00
 - D.....Variance - \$50.00
 - E.....Temporary Use - \$50.00
 - F.....Appeals - \$20.00
 - G.....Subdivision:
 1. Preliminary - \$25.00 minimum plus \$1.00 per unit
 2. Final Plat - \$1.00 per unit
3. Fees are not refundable unless the application is withdrawn prior to the mailing of the notification of the hearing.

Section 2: This Ordinance shall take effect immediately upon its final passage by the City Council and approval by the Mayor.

Passed on first reading at a regular meeting of the Wilsonville City Council this 28th day of August, 1972; ordered posted in three (3) public and conspicuous places in the City of Wilsonville for a period of five (5) consecutive days as required by the Wilsonville City Charter, and to come up for final reading and action of the Wilsonville City Council at a regular meeting thereof to be held on the 11th day of September, 1972, at the hour of 7:30 o'clock p.m., Oregon Daylight Saving Time, at the Wilsonville City Hall.




