I, the undersigned, City Recorder of the City of Wilsonville, State of Oregon, being first duly sworn on oath depose and say:



ORDINANCE NO. 169

AN ORDINANCE AUTHORIZING CONTRACT FOR PURCHASE OF EQUIPMENT; AUTHORIZING INTRA-FUND TRANSFERS FOR PAYMENT OF PURCHASE PRICES IN EXCESS OF BUDGETED AMOUNT; AND DECLARING AN EMERGENCY

WHEREAS, the City of Wilsonville has heretofore advertised and received bids which were opened at the City Hall on November 24, 1980, for purchase of certain equipment; and

WHEREAS, the bid specifications for the equipment were prepared by the City public works director, Larry Blanchard, and calls for bids were duly and regularly published in a manner and for the time required by law; and

WHEREAS, bids were publicly opened and read out loud at the Wilsonville City Hall on November 24, 1980, and the results of the bidding was reported to the Mayor and the Wilsonville City Council by memorandum of public works director, Larry Blanchard, dated November 25, 1980, and additionally by oral report to the City Council at its regular meeting on Monday, December 1, 1980, at which time Larry Blanchard presented a letter from Diesel Service Unit Company withdrawing their bid and, therefore, the recommendation ultimately was to accept the next lowest bid from Wentworth Chevrolet and the memorandum report and oral reports, together with the bids, were considered by the Wilsonville City Council at their regular meeting. A copy of the memorandum is marked Exhibit A and

attached by reference herein as if fully set forth.

WHEREAS, the Wilsonville City Council, as the City's contract review board, considered the bids and specifications for the equipment, and reports and recommendations of its public works director and determined the following bids to be acceptable:

RECOMMENDATION

Accept bid from Goodwin Brothers GMC Truck for the bid amount of 16,896.63 for 1981 Model C7 D04Z GMC flat bed dump. The reason for not accepting the low bid is that the truck bid by Francis Ford does not have the equipment on it as specified in the bids. There are a number of exceptions to the bid by Francis Ford;

1. A 22.5 quart cooling system instead of a 33 quart system.
2. Single horizontal exhaust system instead of a dual horizontal stainless steel exhaust system.
3. 370 V-8 2V 154 net H.P. gas engine @ 3600 RPM instead of a not less than 350 V-8 188 net H.P. @ 3800 RPM.
4. 13" woven asbestos clutch instead of 13" cerametalix clutch.




