ORDINANCE NO. 232

AN ORDINANCE AMENDING SECTION 5.070 OF THE WILSONVILLE CODE.

WHEREAS, the City Council of the City of Wilsonville has determined that it is in the best interest of the welfare and public safety of its citizens to amend the Traffic Code, Chapter 5 of the Wilsonville Code, to regulate the parking of boats, trailers, and other non-motorized equipment on city streets;

NOW, THEREFORE, the City of Wilsonville ordains as follows:

1. Section 5.070 of the Wilsonville Code shall be amended to read as follows:

"General Regulations - Storage of Motor Vehicles and Other Property on Streets. No person shall store or permit to be stored on a street or other public property, without permission of the council, a motor vehicle, boat, trailer, camper, mobile home, travel trailer, or other personal property for a period in excess of seventy-two (72) hours. Failure to move any of the above-listed motor vehicles, boats, trailers, campers, mobile homes, travel trailers, or other personal property for a period of seventy-two (72) hours shall constitute prima facie evidence of storage."

2. It being determined by the Wilsonville City Council that an emergency exists, this Ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.

Submitted to the Council and read the first time at a regular meeting thereof on the 16th day of May, 1983, and scheduled for second reading at a regular meeting of the Council on the 6th day of June, 1983, commencing at the hour of 7:30 o'clock p.m., at the Willamette Valley Wesleyan Church.
