## ORDINANCE NO. 242

AN ORDINANCE OF THE CITY OF WILSONVILLE REPEALING ORDINANCE NO. 22 AND SECTIONS 9.300, 9.310, 9.320, 9.322, 9.324, 9.326, 9.328, 9.330, 9.340, 9.350, 9.352, 9.360 AND 9.370 OF THE WILSONVILLE CODE, DESIGNATED AS "FIRE PREVENTION CODE"; REPEALING ALL OTHER ORDINANCES AND RESOLUTIONS AND PARTS OF ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH

THE CITY COUNCIL OF THE CITY OF WILSONVILLE DOES ORDAIN
AS FOLLOWS:

Section 1. That Ordinance No. 22 and the portion of the Wilsonville Code of the City of Wilsonville, known as "Fire Prevention Code", Sections 9.300, 9.310, 9.320, 9.322, 9.324, 9.326, 9.328, 9.330, 9.340, 9.350, 9.352, 9.360 and 9.370 and all other ordinances and resolutions and parts of ordinances and resolution in conflict therewith be repealed.

Section 2. The 1981 Fire Prevention Code, as published by the Tualatin Rural Fire Protection District has been adopted by the City Council of the City of Wilsonville by Resolution No. CLXX (170), effective as of June 1, 1981.
