## ORDINANCE NO. 251

AN ORDINANCE ESTABLISHING PARKING REGULATIONS ON THE RIGHT-OF-WAY OF THE STREET SECTIONS IDENTIFIED ON THE MAP IN ATTACHED EXHIBIT "A"; APPROVING THE INSTALLATION OF "NO PARKING ANYTIME" SIGNS ON SAID STREET SECTIONS; AND APPROVAL FOR THE APPROPRIATION OF FUNDING FOR THE INSTALLATION OF THE SIGNS AS DESIGNATED IN EXHIBIT "A".

WHEREAS, the Wilsonville City Council, at its regularly scheduled Council meeting held December 19, 1983, in the Council Chambers, 30000 SW Town Center Loop East, at 7:30 P.M. did approve the recommendations from the Traffic Safety Commission in a report titled "TRAFFIC SAFETY COMMISSION RECOMMENDATION 'NO PARKING' CHARBONNEAU AREA STREETS TS-5-83-1". The report is attached hereto as Exhibit "A".

THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. "No Parking Anytime" signs shall be installed on both sides of all public street sections as identified by the map in the attached Exhibit "A" incorporated by reference herein. The sign shall be installed in accordance with the specifications as recommended in the Uniform Traffic Safety Code.

<u>Section 2.</u> The City Administrator shall cause the appropriate installation of signing to be completed in

accordance with this ordinance.

Section 3. Funds for the installation of the materials for signing hereby approved by adoption of this ordinance, shall be allocated from Account Number 07-65-60710.

Section 4. It being determined by the Wilsonville City Council that an emergency exists, this ordinance shall take effect immediately upon final reading and passage by the Wilsonville City Council.

### PREVIOUS COUNCIL ACTION

#### SUMMARY

1. The City was presented with a request from all Homeowners Associations in the Charbonneau area to restrict parking in the street section as indicated in Exhibit #1.

2. Staff presented this request to the Traffic Safety Committee at their regularly scheduled meeting, held August 29, 1983, in the Wesleyan Church at 7:00 P.M. The Traffic Safety Commission recommended that a Traffic Safety Analysis be completed and a poll of the residents of the area be done to determine their feeling on the issue.

3. Staff completed a Traffic Safety Analysis and a telephone poll and presented the results of the poll to the Traffic Safety Committee at a special meeting on November 15, 1983 at 7:00 P.M. in the Wesleyan Church. The traffic analysis and resident's poll are attached as Exhibit #2

### RECOMMENDATIONS

1. The City Council approve the installation of "No Parking Anytime" signs for the streets designated in Exhibit #1.

2. The problem of parking in public streets for future residential construction be sent to the Planning Commission for review.

3. The proper ordinance be drafted and sent to Council for final adoption.

### WILSONVILLE TRAFFIC SAFETY STUDY

### Location: Charbonneau District See Map Location No. 5

Existing Conditions: This location located just off French Prairie Road consists of a large residential area having narrow streets and dead-ends with undersized cul-de-sacs. There is little parking available besides driveway parking alloted to property owners. With the exception of a few isolated cases, parking is unrestricted.

Traffic Conflicts: Any additional traffic (visitors) parking in this area usually must park on the streets causing very crowded and potentially dangerous situations for other traffic. Emergency vehicles such as police, fire, and ambulance are potentially faced with restrictive service routes.

<u>Recommendations</u>: It is recommended on-street parking be restricted throughout this area to improve traffic flow and safety. "No Parking" signs should be installed near the entrances to dead-end streets and at both ends with intermittent signing on the through streets. No parking zones should be be reinforced by painting the curbs yellow.




