## ORDINANCE NO. 265

AN ORDINANCE AUTHORIZING CITY RECORDER TO ESTABLISH LIEN DOCKET FOR BOECKMAN BRIDGE LOCAL IMPROVEMENT DISTRICT NO. 6 AND AUTHORIZING ISSUANCE OF CITY OF WILSONVILLE BONDS PURSUANT TO BANCROFT BONDING ACT.

WHEREAS, notice of right to apply by property owners benefited by Local Improvement District No. 6 for installment payment of assessment, together with a written application, was duly sent to each property owner benefited, on October 16, 1984 and more than ten days have elapsed for filing said application under ORS 223.210.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. The City Recorder shall enter in a lien docket as and for taxes assessed and levied in favor of the city and for the amounts of such unpaid assessments therein docketed, with interest on the unpaid assessments at the rate of ten percent (10%) per annum as against each property benefited by City Council action, said entries to be in accordance with ORS 223.230.

- 2. Upon making up said lien docket pursuant to ORS 223.230, the issuance of the City of Wilsonville Bonds pursuant to ORS 223.235 is hereby authorized, and the City Administrator and City Recorder shall take all necessary steps to cause the issuance of the City's bonds in convenient denominations and in all equal to the total amount of unpaid assessments for the improvements of local improvement district No. 6, and for which applications to pay under the Bancroft Bonding Act have been filed, as shown by the bond lien docket.
- 3. In the event no applications are received within a thirty (30) day period from October 16, 1984, then collection proceedings shall be enforced in accordance with the provisions of ORS 223.505 to 223.650.
- 4. It being determined by the Wilsonville City
  Council an emergency exists, this ordinance shall
  take effect immediately upon final reading and
  passage by the Wilsonville City Council.
