AN ORDINANCE DECLARING AND AUTHORIZING THE VACATION OF PUBLIC SANITARY SEWER EASEMENTS LOCATED WITHIN THE TOWN CENTER, CITY OF WILSONVILLE, CLACKAMAS COUNTY, OREGON.

WHEREAS, the Capital Realty Corporation has filed with the City a petition setting forth a description of public sanitary sewer easements proposed to be vacated as attached in Exhibits "A" and "B"; and
