

ORDINANCE NO. 447

AN ORDINANCE ADOPTING THE PROPOSED CITY OF WILSONVILLE WASTEWATER TREATMENT PLANT FACILITIES PLAN AS A COMPONENT OF THE CITY'S COMPREHENSIVE PLAN AND DECLARING AN EMERGENCY.

WHEREAS, the consulting firm of CH2M Hill has prepared the City of Wilsonville Wastewater Facility Plan; and

WHEREAS, CH2M Hill and staff have presented said Plan along with the staff report to the Planning Commission on June 12, 1995; and

WHEREAS, the Wilsonville Planning Commission conducted a public hearing concerning the Facility Plan and adopted Resolution No. 95PC14, recommending that the Wilsonville City Council adopt the proposed Wastewater Treatment Plan Master Plan, and;

WHEREAS, at the Planning commission meeting, Mr. John Davenport, and Mr. Robert Thomas, representing Coca-Cola Bottling company, expressed concern that the Plant may be undersized to support continued growth for 20 years; and

WHEREAS, the Planning Commission requested that staff meet with Coca-Cola Bottling Company representatives and resolve differences as to required plant capacity; and

WHEREAS, Coca-Cola submitted additional data supporting their contention that the plant size needs to be further increased to support growth; and

WHEREAS, the lack of reliable metering data prior to March 1994, severely limits our ability to translate past wastewater treatment records with projected future requirements; and

WHEREAS, CH2M Hill indicates that the plant size can be increased with only moderate increases in construction costs.

NOW, THEREFORE, THE WILSONVILLE CITY COUNCIL ORDAINS AS FOLLOWS:

SECTION I. DETERMINATIONS AND FINDINGS:

A. The Wilsonville City Council hereby adopts and incorporates by references, the facts and findings contained in the City of Wilsonville Wastewater Facility Plan that has been prepared by CH2M Hill.

B. The Wilsonville City Council hereby adopts and incorporates by reference the facts and findings contained in Addendum No. 1 to the City of Wilsonville Wastewater Facility Plan,


which increases the treatment capacity for Peak Month Average Daily BOD and for Peak Month Average Day Total Suspended Solids to 8,580 pounds per day each.

C. The City of Wilsonville Wastewater Facility Plan, which is identified as Exhibit "A", and the staff report, which is identified as Exhibit "B", and the Planning Commission Resolution No. 95PC14, which is identified as Exhibit "C", along with the public testimony, clearly supports the finding that it is necessary to adopt a new City of Wilsonville Wastewater Facility Plan that meets the present and future needs of the citizens and business community of the City of Wilsonville.

D. The City Council finds that the adoption of the City of Wilsonville Wastewater Facility Plan is necessary to help protect the public health, safety and welfare of the municipality by ensuring that there will be adequate capacity within the City's wastewater system.

SECTION II. EFFECTIVE DATE OF ORDINANCE:

SUBMITTED to the Wilsonville City Council and read for the first time at a regular meeting thereof on the 17th day of July, 1995, and scheduled for second reading at a regular meeting thereof on the 7th day of August, 1995, commencing at the hour of 7:00 p.m. at the Community Development Annex.
