

RESOLUTION NO. 2032

A RESOLUTION ACKNOWLEDGING THE CERTIFICATION OF THE ELECTION RESULTS OF THE NOVEMBER 7, 2006 GENERAL ELECTION BY THE CITY RECORDER THE CITY'S ELECTION OFFICIAL.

WHEREAS, at the General Election held November 7, 2006 the electorate of the City of Wilsonville cast ballots for Ballot Measure 3-231, A five-Year Local Option Levy for Public Safety, Library and Parks; and

WHEREAS, the electorate of the City of Wilsonville to cast ballots for two City Councilor positions, and;

WHEREAS, the election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for both Clackamas and Washington counties was duly received by the City Recorder on November 28, 2006, copies of which are attached hereto and incorporated by reference.


2. That Ballot Measure 3-231, a Five Year Local Option Levy for Public Safety, Library, and Parks, having received a majority of negative votes has failed.

3. That Alan Kirk was elected to the office of City Councilor, for a four-year term commencing January 1, 2007.


4. That Michelle Ripple was elected to the office of City Councilor, for a four-year term commencing January 1, 2007.

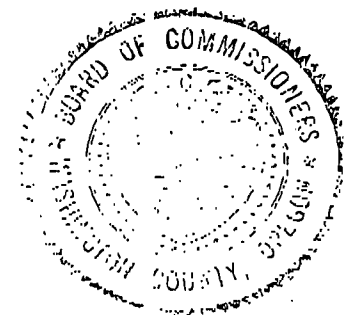

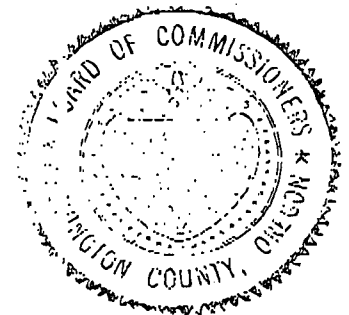

1. A Regular Election was held November 7, 2006, for the electorate of the City of Wilsonville to cast ballots for two City Councilor positions.
2. Ballot Measure 3-231 A Five-Year Local Option Levy for Public Safety, Library, and Parks was also voted upon during the November 7, 2006 General Election.
