A RESOLUTION DESIGNATING GELCO GROUTING SERVICE AS LOW BIDDER FOR THE 1982-83 SANITARY SEWER/STORM SEWER MAINTENANCE PROGRAM; DESIGNATING STAFF TO PREPARE THE MAINTENANCE CONTRACT AGREEMENT; AND APPROVING GELCO GROUTING SERVICE TO REPAIR MANHOLES FOR THE 1981-82 INFILTRATION/INFLOW CORRECTION PROJECT.

WHEREAS, the City Staff has prepared a report on the above captioned subject which is attached hereto as Exhibit A, and

SUBJECT: Approval Infiltration/Inflow Maintenance Agreement Contract

At the April 5, 1982, Council Meeting I submitted a memo dated April 5, 1982, which asked the City Council to approve the following:

1. Approve staff to prepare a maintenance agreement contract with Gelco Grouting Service for 1981/82 Budget year for the following:
 - a. Cleaning sanitary sewer - storm sewer lines
 - b. Air Testing - TV Inspection of sanitary sewer lines
 - c. Grouting sanitary sewer lines and manholes
 - d. Emergency repair to sanitary sewer and storm lines regarding the above
2. Approve Gelco Grouting Service to seal known leaks in manholes at the established rate in the agreement above.

The Council asked staff at the April 5, 1982, Council Meeting to prepare the necessary information to get proposals back from prospective vendors, contractors, sale sources, or whatever it is being called.

Staff and Westech Engineering Inc. together completed a contract proposal (attached) which was sent out to the two (2) known remaining contractors engaged in this type of work. Gelco Grouting Service and Chem Seal both of Salem sent in their bid proposals.

The proposal were bid in 4 different categories. (See attached bid result form)

1. Sanitary Sewer Cleaning
 - a) Gelco Grouting consistantly was low bid in this category with total cost for the 82/83 cleaning program of \$16,618.16 total as opposed to \$36,270.50 bid by Chem Seal.
2. Storm Sewer Cleaning
 - a) Gelco Grouting Service again was low bidder for a total bid of \$16,017.70 as opposed to Chem Seal at \$61,335.00.

3. Infiltration/Inflow Control

Since this program is contingent upon problems found by Smoke Testing or flow measurements a total was not given, however by using hypothetical numbers for each section we can establish a final cost. In all categories Gelco was the low bidder except for a few however the cost difference is not significant enough to change the difference in bid for cleaning in 1 & 2 above.

4. Emergency Repairs

Gelco Grouting Service was significantly low bidder in all categories under Emergency Repairs.

Recommendations

1. Designate Gelco Grouting Service as low bidder, and accept their bid for the 1982/83 sanitary sewer/storm sewer maintenance program.
2. Designate staff to prepare the maintenance contract agreement for the 1982/83 Budget year.
3. Approve the contractor to complete the 23 manhole sealing repairs under the 1981/82 I/I Correction Project. Expenditures not to exceed \$6,000.00
