As indicated in a memo dated July 15, 1982, and titled "APPROVAL TO CALL FOR BIDS - 1st QUARTER (July through September) MATERIALS AND EQUIPMENT" many items were purchased as was originally approved by Council. However, there were a number of items which required an R.F.P. (Request for Proposals) by a minimum of 3 vendors whenever possible, in order to bring to Council for final approval.
