AUDIT.


WHEREAS, the city staff has prepared a report on the above

I have reviewed the seven proposals received to do the City's audit for FY 1985-86, 1986-87 and 1987-88. A complete listing is attached. It is my recommendation we award the contract to Gregor Professional Corp. of Eugene Oregon.

Not only are they low bid, but in my opinion, the proposal they submitted discloses a well established history of successful audits for various cities in Oregon. I contacted the City Administrator or Finance Director in 4 of the 15 cities listed in their proposal. All cities I contacted were well satisfied with the service they have received from the Gregor firm.

Most of the firms who responded to the request for proposal are obviously well qualified to do the City's audit. However, I can see no significant factors that would justify not recommending the low bid vendor, Gregor Professional Corp.
