

**RESOLUTION NO. 618**

**A RESOLUTION AMENDING SECTION 8 OF RESOLUTION  
NO. 597, RULES AND REGULATION FOR COMMERCIAL  
AND RECREATIONAL HOT AIR BALLOONS**

WHEREAS, the Parks and Recreation Commission has recommended an addition to the above captioned subject;

WHEREAS, the City Council has duly considered the subject and recommendations by the Parks and Recreation Commission; and

WHEREAS, interested parties, if any, have had an opportunity to be heard on the subject.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Wilsonville does hereby adopt the Park and Recreation Commission's recommendation as follows:

1. Section 8 of Resolution No. 597, is amended as follows:

**HOT AIR BALLOONS**

- a. Commercial - One year permit from July 1 to June 30.

Commercial Permit - \$100.00

Business License - \$50.00


- b. Recreational - One year permit from July 1 to June 30.

Park Permit - \$50.00

c. Rules & regulations - Commercial & Recreational Hot Air Balloons:


1. Provide Certificate of Insurance as set forth in Section 10.
2. Provide 5 X 7 Color Photograph of Balloon.
3. Provide Registered N Number (N#).
4. Must Abide by all F.A.A. Regulations which includes maintaining a 500' minimum altitude over all residential areas.
5. No landings within the City Limits without prior written permission of property owner.
6. Balloon operations will comply with all City Zoning Ordinances.

ADOPTED by the City Council of the City of Wilsonville at a regular meeting thereof this 15th day of June, 1987, and filed with the Wilsonville City Recorder this same date.

**SUBJECT: HOT AIR BALLOON RULES & REGULATIONS**

Resolution No. 597, establishing fees for reservations of park and recreation facilities was adopted by the City Council on January 20, 1987. With the coming of hot air balloon season, a request has been made to amend this resolution. The requested changes include:

1. Changing the permit year from a calendar year to a fiscal year to coincide with the issuing of Business Licenses by the City.
2. Changing Rule #3 requiring a Registered Serial Number to requiring a Registered N Number.
3. Changing Rule #4, adding that the F.A.A. regulations include maintaining a minimum altitude of 500' over residential areas.
4. Changing Rule #5 to read, "No landings within City Limits without prior written permission of property owner".
5. Adding Rule #6, stating that, "Balloon operations will comply with all City Zoning Ordinances."

The Parks and Recreation Commission recommends these changes to Council for adoption.
