In the near future the city will have several construction projects underway including the new library, restroom facilities in Boones Ferry Park and Wilsonville Memorial Park, and construction of the water system improvements.

In the past, it is my understanding that the City Council has waived fees for certain city projects (City Hall;, Community Center). However, I am not aware that the Council has established a set policy on fees for city projects.

The fees can cover a wide variety of charges including Planning Department, systems development, water connection, sewer, parks development, etc.. Some of the fees are for specific purposes and funds such as systems development, water, sewer, etc. while others are simply general revenues which wold be placed in the general fund (planning, building permits, etc..). While we should certainly account for the fees to determine what the true value of a project would be, I'm not so sure that we should actually assess the fees and transfer money from one fund to another. What that does in effect is drive the cost of a project up and in some cases, such as the library, the taxpayers will pay more for the project. In other cases, such as the water system improvements, fees will add to the cost of the amount the city has to borrow to complete the project.

The following is an estimated breakdown of the fees the city would have to pay on a \$900,000, 7,500 square foot library:

As can be seen, the cost of the project is raised considerably by assessing the fees. Good management dictates that the fees be accounted for in reaching a true cost of a project. However, public projects should be completed at the lowest possible cost and to actually pay the fees seems contrary to the purpose.

Recommendation - The Council adopt Resolution No. CB-R-295-87 to provide a waiver of fees for city sponsored and constructed projects.
