

RESOLUTION NO. 998

A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE MARCH 23, 1993 SPECIAL ELECTION.

WHEREAS, at the Special Election held March 23, 1993, the electorate of the City of Wilsonville cast ballots for a three year serial levy for City's law enforcement; and

WHEREAS, the election of the registered voters of Clackamas County and Washington County was conducted at the polls; and

WHEREAS, the County Clerks of Clackamas and Washington Counties, who by statute, are in charge of conducting all elections, have filed an abstract of the tally of votes cast at the election, which tally was received on May 10, 1993.




2. Based upon the adopted canvass of votes, the City Council affirms that the election was favorable for continuation of the City's law enforcement.
