

RESOLUTION NO. 1391

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE MAY 20, 1997,
SPECIAL MAIL-IN ELECTION, MEASURE 3-92.**

WHEREAS, at the special election held May 20, 1997, the electorate of the City of Wilsonville cast ballots in a measure election for Measure 3-92;

WHEREAS, the question submitted to the voters stated, "Shall Wilsonville levy 50¢/\$1,000 in 1997-2000 outside the tax base for parks and street maintenance, youth recreation, gang prevention?"; and

WHEREAS, the election of the registered voters of Clackamas County was conducted by mail-in ballot; and



1. That the City Council of the city of Wilsonville does hereby adopt the votes as follows:


