#### **RESOLUTION NO. 1486**

A RESOLUTION OF THE CITY OF WILSONVILLE APPROVING THE BID PROCESS; ACCEPTING THE LOWEST RESPONSIBLE BID; AWARDING THE CONTRACT TO EAGLE ELSNER, INC., THE LOWEST RESPONSIBLE BIDDER; VERIFYING FUND AVAILABILITY; FOR THE PROJECT COMMONLY REFERRED TO AS STREET MAINTENANCE PROJECT 1998-1.

WHEREAS, the Street Maintenance Project 1998-1 was duly advertised for competitive bids in the Daily Journal of Commerce, a newspaper of general circulation; and

WHEREAS, five sealed bids were received prior to 2 p.m. local time, June 9, 1998, at the Community Development Department, 8445 SW Elligsen Road, Wilsonville, Oregon; and

WHEREAS, the bid submitted by Morse Brothers, Inc. was returned unopened pursuant to project contract document requirements due to failure to have prequalification materials on file with the City Engineer; and

WHEREAS, the remaining four bids were then opened individually, and separately read aloud after 2 p.m., local time, June 9, 1998. The Summary of Bids is marked Exhibit "A", attached hereto and incorporated herein; and

WHEREAS, Eagle Elsner, Inc. submitted the lowest responsible bid, in the amount of \$98,032.45; and

WHEREAS, the City desires to execute a Construction Contract Agreement in a timely manner; and

WHEREAS, as part of the 1998-1999 budget adopted on June 1, 1998 by Resolution No. 1475, an appropriation of \$426,000 was included for road maintenance regulatory services; and

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The City Council acting as the Local Contract Review Board finds and concludes that:
  - a. The bid submitted by Morse Brothers, Inc. was accurately and correctly returned unopened pursuant to contract documents prequalification requirements.
  - b. Eagle Elsner, Inc. is the lowest responsible bidder.

- 2. Subject to the final review and approval of the City Engineer and in accordance with the provisions of Oregon Revised Statutes, Chapter 279, Public Bids and Contracting; Wilsonville Code 2.3.14, Contracts with the City; and the Attorney General's Model Rules which the City has adopted as its contracting rules; the City Council acting as the Contract Review Board hereby awards the contract for construction to Eagle Elsner, Inc in the amount of \$98,032.45.
- 3. Subject to final completion of all improvements specified in the contract documents and any supplementary changes, the City Engineer is authorized to certify the required improvements complete and make final payment including release of retainage.
- 4. The City Engineer is authorized to approve change orders to this contract as required provided, however, that the total cost does not exceed the approved budget for this project.


