 Zone Order 98PC03 is hereby adopted. WC 4.121(5)(c) is amended to read, "Minimum Frontage: Seventy-five (75) feet or a minimum of thirty (30) feet of appropriate access if this is provided either through fee ownership or by easement."

- 2. The amendment to the Zoning Chapter of the Wilsonville City Code requested is hereby approved as described. The City Council adopts the findings contained in Planning Staff Report dated August 5, 1998, (Exhibit A).
- 3. Section 1 and 2 are to be implemented as follows:
